NURS 610 Translational Scholarship for Evidence-Based Practice Review of Literature Paper Guidelines

Step One: Create a Document

• Create a new document and label it "ROL" or something easily recognizable.

Step Two: Edit Initial Papers

- Edit the three papers you got back from your professor.
- These include the Focus Paper and the two Evidence Appraisal Summaries (1-5 and 6-10)
- If these three initial papers are edited before even pasting them into your ROL document, you will be a couple of steps ahead.
- First to be pasted into the ROL paper is the Focus Paper. This will then serve as the overall introduction to the ROL paper.
- It should have the following subheadings.

Problem Identification

Potential Quality Improvement Project Identification

Baseline and Benchmark Data

Potential Quality Improvement Project

Step Three: Identify The Main Ideas and Put Them in Your Paper as Subheadings

- Organize your paper with lots of Levels 1 and 2 subtitles like in the box below.
- Include a subtitle that describes the content of each study you include.

Growth and Development of a Butterfly (Level I Heading)

The Egg (Level II Heading)

Stages of Caterpillar Development (Level II Heading)

An instar is defined as . . .

• Write a few sentences that introduce the nature of each main idea. Be sure to define each important concept. Assume the reader doesn't know even fundamental concepts.

- Then, paste in the summary you wrote for the various article appraisals. Do this according to the main ideas you have developed. You can rearrange them later.
- In between each summary, write a sentence that serves to transition to the next one.
- The idea behind transition statements is that they will help synthesize the evidence, a main goal of a review of literature.
- Sample transition statements are below in the box.
- Keep doing this until all of your summaries (from the Evidence Appraisal Summary documents) have a home in your paper.
- As you go, cut out the reference and move it to the last page of your document.

Examples of Transition Sentences to Put Between Summaries

- This study by Twibell et al. (2023) showed that falls-related behaviors may be reduced by viewing a video about falls. Elsewhere at about the same time, Grady and Brady (2022) studied another intervention that may reduce the incidence of falls: hourly rounds.
- The findings of this study by Twibell et al. (2023) were supported by similar findings in a study by Grady and Brady (2022) who looked at _______.
- This research by Twibell et al. (2023) is further supported by results of a qualtitative study by Great and Grand (2023) who studied ______.

Examples of a Transition Statement to Put at the Beginning of Each Main Idea Section

Below is an example of a transition from a former student paper on nurse fatigue

• Equally important as the finding that shift work contributes to increased fatigue is the finding that shift work also contributes to factors that reduced the safety of a nurse. Accordingly, a cross-sectional, descriptive study conducted in the Philippines by De Castro et al. (2010) set out to determine _____.

Step Four: Summarize Consistencies Within the Evidence

- Write a paragraph or two about research findings that were *consistent* with the results of other studies.
- These will be the studies that will provide evidence that is useful in the design of a capstone project.

Step Five: Summarize Inconsistencies Within the Evidence

- Write a paragraph or two about research findings that were in*consistent* with the results of other studies.
- These studies may provide some useful evidence, but you will need to use them "with caution", because their findings were inconsistent with the findings of the best studies.

Step Six: Write a Conclusion

- Use this statement: The purpose of this review of literature has been to appraise the research and other evidence that addresses the problem of ______.
- Then, state something about this problem area being one that interests you for the quality improvement process that will become your leadership project.

Step Seven: Edit the References

- You will have copied and pasted the references from the two Appraisal Summary papers.
- Alphabetize them and proofread them for APA accuracy.

Step Eight: Edit

- Edit, edit, edit
- Read through your paper as often as possible.
- Use *Grammarly* or another grammar program.
- Use the *Read Aloud* function in *Word*
